## How we use your data

## Where your data is held

Your personal data is held on secure servers operated by Autism Initiatives UK and agencies contracted by us. We do not transfer your data outside the EEA and we comply with the protection offered to you under the Data Protection Act 2018.

## Data Security

Personal data is collected and stored securely subject to stringent security measures and is protected against misuse.

## The information we collect

As well as name and contact details, we may ask you to supply other information such as the type of organisation you work for, or to tell us if you are a member of the public. We use this information we gather to help us tailor the information we send you to your needs. We may also ask if you are a UK Taxpayer, this is only asked in relation to opportunities to Gift Aid donations in the UK.

## What we do with your data and what we don't do

We use the data you supply to give you information and advice about your enquiry. If you have given your consent, we may communicate with you via e-mail, post or telephone about the activities of the Fundraising department at Autism Initiatives. We never share your data for marketing purposes with any other organisation outside of the Autism Initiatives Group.
